



Membership Fee Regulations

ECOCAMPING Network

as of 01.01.2023

for all participants entering after 01.09.2022

1. Obligation for Membership Fees

Participation in the ECOCAMPING Network is subject to the payment of annual membership fees to ECOCAMPING Service GmbH. The membership fee shall cover all the services designated for the participant (see Rules of Procedure of the ECOCAMPING Network, Paragraph 4).

2. Membership Fees

The annual amount of the membership fees for new network participants who enter after the 01.09.2022 is **depending on the number of pitches** as follows:

Up to 100 pitches	750,00 €
Up to 200 pitches	950,00 €
Up to 500 pitches	1.250,00 €
Up to 1.000 pitches	1.450,00 €
Up to 2.000 pitches	1.850,00 €
Above 2.0000 pitches	2.450,00 €

The number of pitches includes all tourist pitches, permanent pitches and non-parcelled rental areas. Tourist pitches include pitches for tourists, as well as special pitches for recreational vehicles, pitches leased to external lessors, and also rental units, such as rental caravans, rental tents, mobile homes / bungalows, basic units, like huts or sleep barrels, group accommodations, holiday houses, holiday flats/ apartments, guest rooms / hotel rooms and further rental units. Non-parcelled spaces are counted by the equivalent of 250 m² as one tourist pitch.

The annual amount is calculated on the basis of the information given to ECOCAMPING Service GmbH by the campsite operator at the time of the last ECOCAMPING consultancy session or on the basis of any changes he has communicated to ECOCAMPING Service GmbH by December 31st.

The membership fees set out in the Membership Fee Regulations are net amounts and in each case the Value Added Tax currently in force shall be added to the invoiced amount.

3. Due Date and Method of Payment

The annual membership fee for the following year shall be invoiced in every case in the September of the current year.

In every case payment shall be due 10 days after invoicing. Payment in cash of the membership fee shall not be accepted. Payments must be transferred to the account of ECOCAMPING Service GmbH

In the first instance the membership fee shall be due before the end of the first full month of receipt of the ECOCAMPING MANAGEMENT label.

In the event that use of this label commences during a calendar year, the annual fee shall be calculated in twelfth parts of the basis for calculation of membership fees specified in Paragraph 2. The amount shall be calculated with effect from the month in which the label was granted.

In the event that use is terminated before the end of the calendar year, any extra membership fees already paid shall not be refunded

Any outstanding payments of membership fees are to be made by the end of the contract term in accordance with the payment methods specified above.

4. Debt Collection Procedure

In the event that a participant falls into arrears with the payment of his membership fees by a period of more than one month from the due date for payment (Paragraph 3), ECOCAMPING Service GmbH reserves the right to apply for a judicial order for payment.

5. Amendment of the Membership Fee Regulations

Membership fees shall be determined by the Executive Board of ECOCAMPING Service GmbH in accordance with the Rules of Procedure of the ECOCAMPING Network (cf. Paragraph 6). The Executive Board has to decide about an amendment of the Membership Fee till 1st September.

6. Entry into force

These Membership Fee Regulations have been adopted by the Executive Board of ECOCAMPING e.V. and shall come into effect on 01.01.2023.
